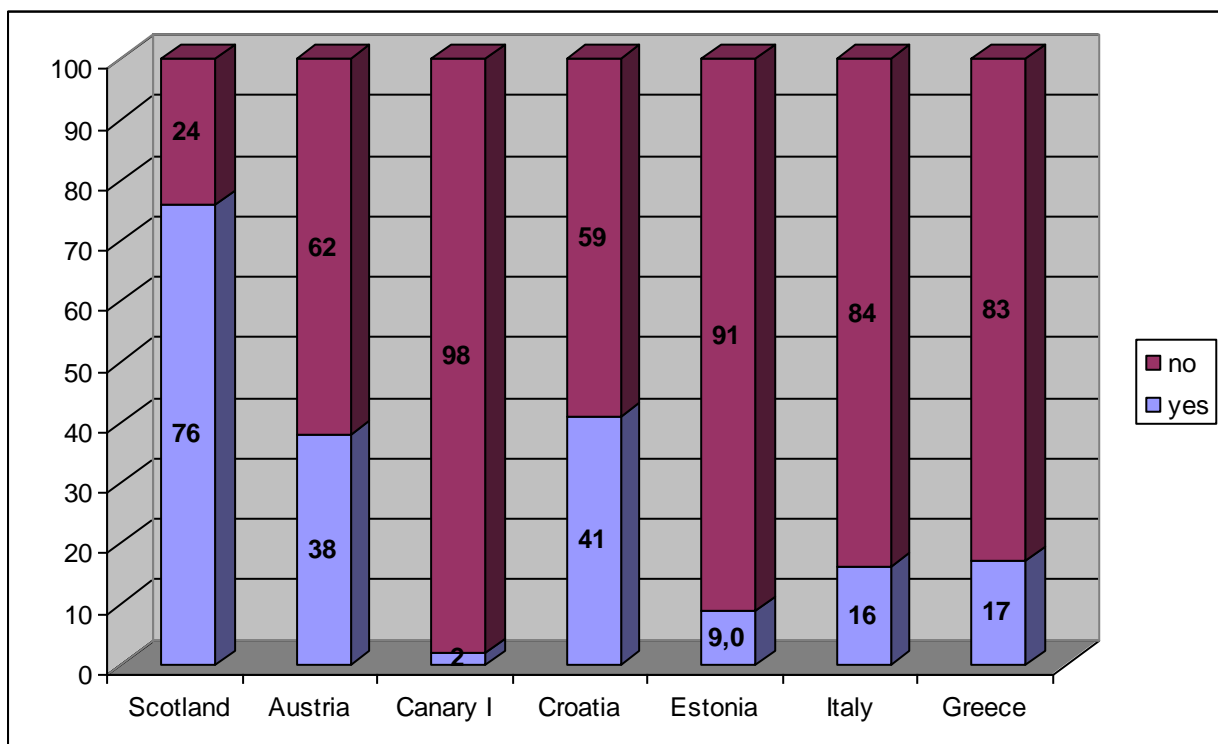

Restricted family budget



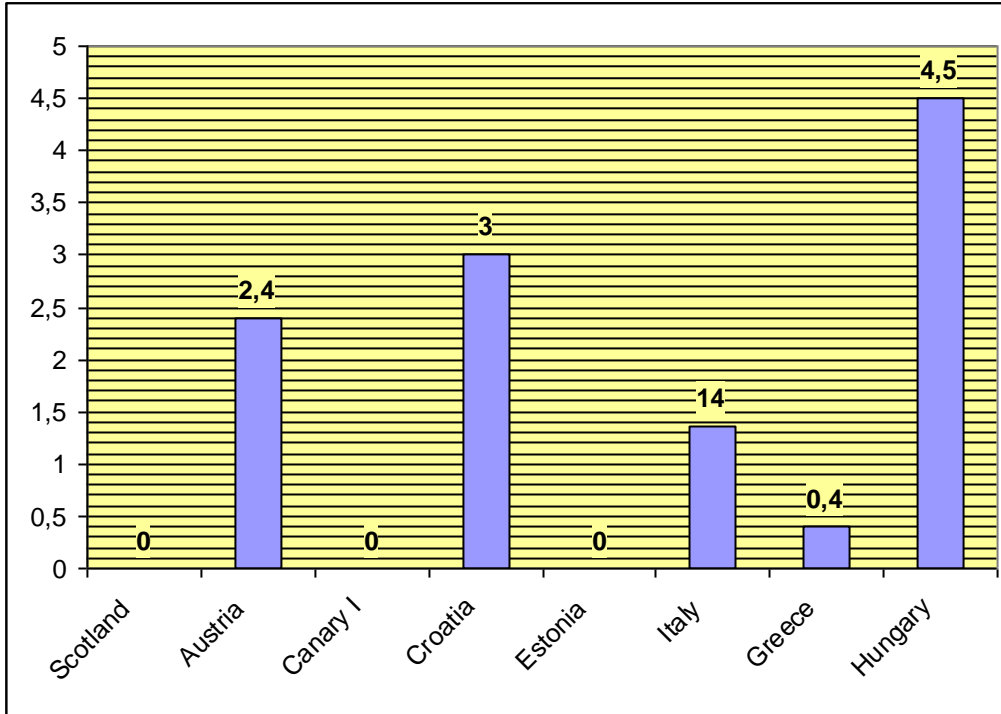

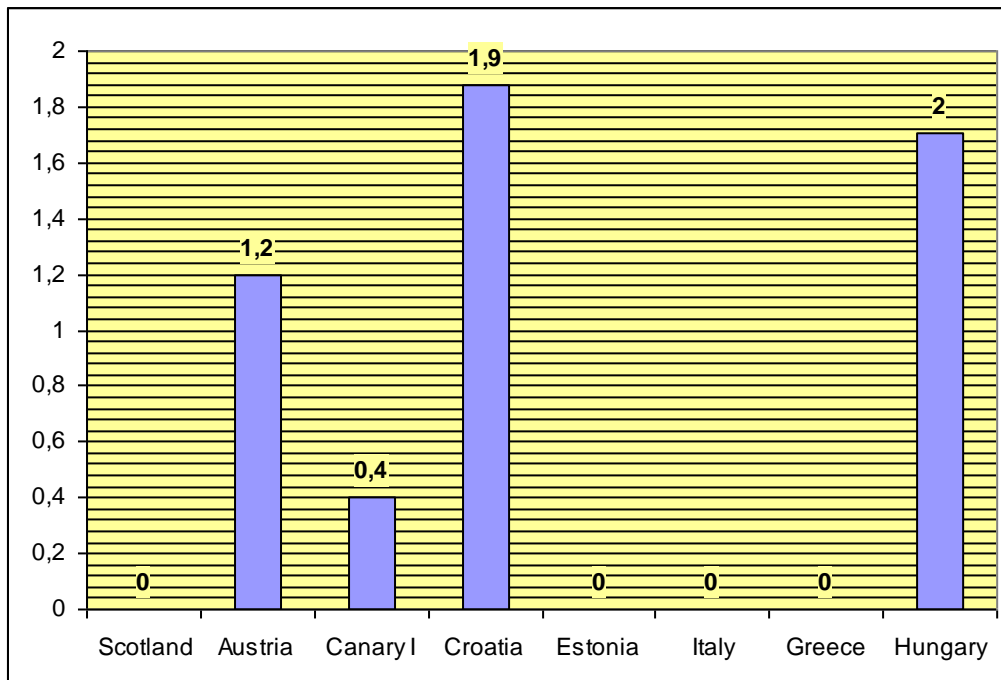

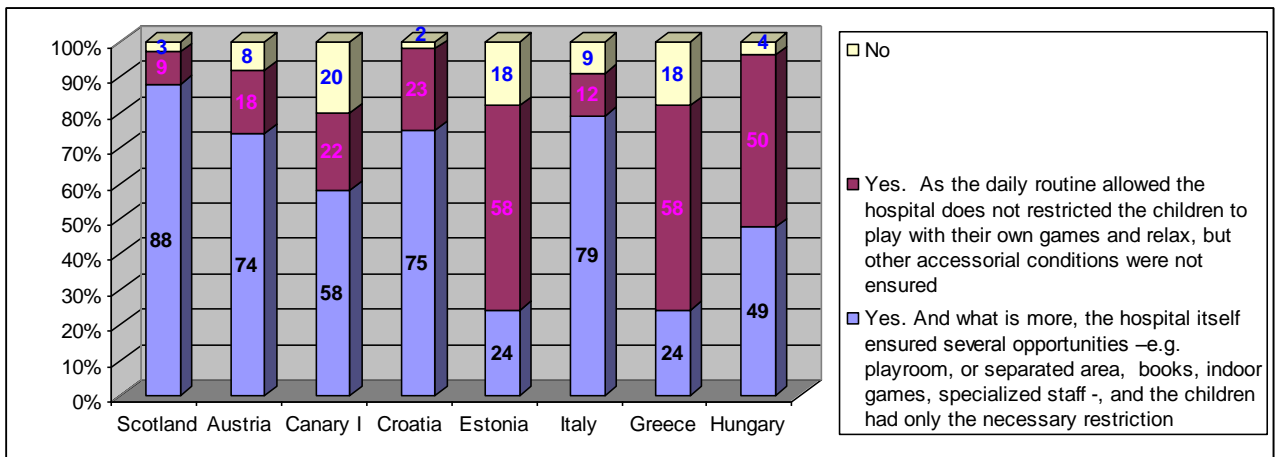


14. If the child's health condition was good enough to play/relax/study in the hospital were opportunities offered for? (What description is the most correct?)

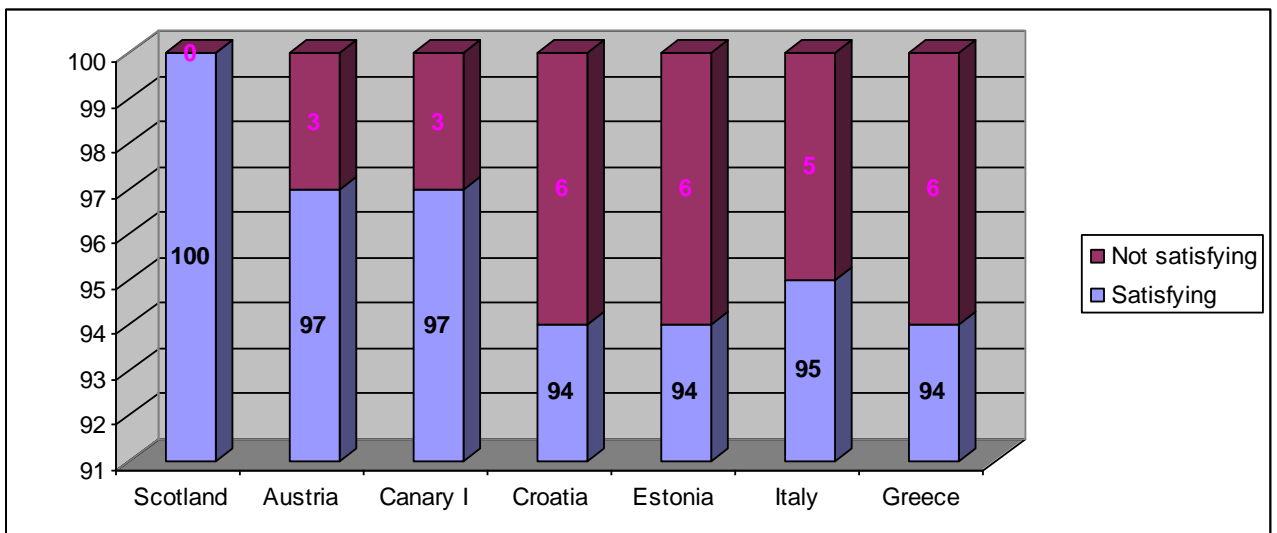
Yes. As the daily routine allowed the hospital does not restricted the children to play with their own games and relax, but other accessorial conditions were not ensured
